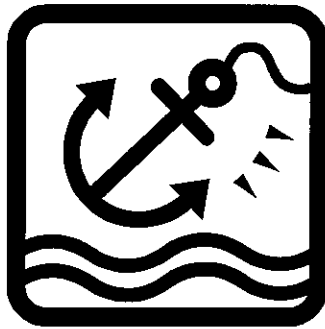


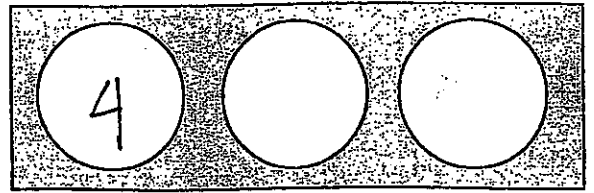

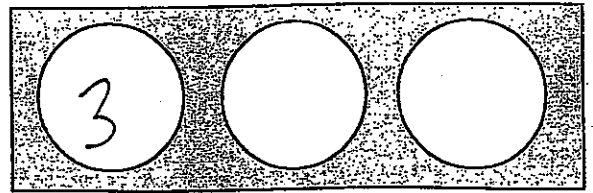

case of an emergency.

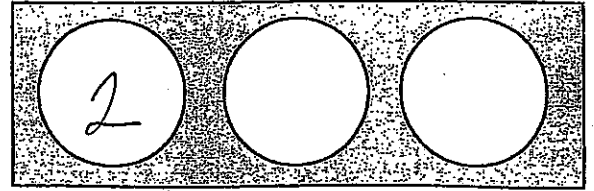

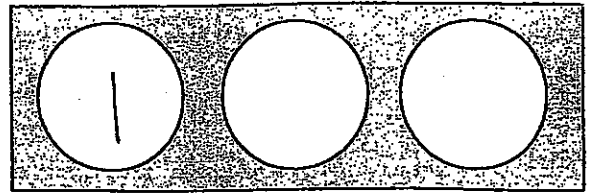
